

## ***Milan School Board Meeting***

Tuesday, January 23, 2007  
Milan Village School Library

### I. Call to Order

Shute called the meeting to order at 6:33 PM.

### II. Written Communications

- Letter of resignation from School Board received from Jacky Quintal effective March 12, 2007.

Shute read letter of resignation.

**Motion made by Quintal to accept letter of resignation from Quintal. Motion seconded by Shute. No discussion. Vote: 2-0. Motion approved.**

### III. Interviews for School Board Vacancy

Bousquet introduced Kevin Evans. Quintal asked Evans if he would like to speak to the Board. Evans explained that he would like to have his civic activities in Milan, instead of in Concord. He was aware of issues the town was facing, and wants what is best for academics and children at the school. He discussed his experience on running a budget for Dartmouth and would be able to apply his knowledge to the district's budget. He explained his background in land management and that he is self motivated.

Quintal asked how Evans would handle nonpublic meetings and being bound to not discussing issues with anyone. Evans responded that he can deal with confidentiality and provided an example.

Quintal asked if Evans had a pre-planned agenda for wanting to come onto the Board. Evans responded that he wanted to help the community and to become more involved.

Quintal spoke on how well Evans handled himself on the SAU Withdrawal Committee.

**Motion made by Quintal to appoint Evans to replace the vacant position on the school board. Motion seconded by Shute. No discussion. Vote 2-0. Motion approved.**
